1. GENERAL REGULATIONS

The 22nd Edition of Crystal Skate 2026 will be conducted in accordance with the ISU Constitution and General Regulations 2024, the Special Regulations & Technical Rules Single & Pair Skating and Ice Dance 2024, and the relevant ISU Communications.

Participation in the competition is open to all Competitors who belong to the ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the ISU Member by which they have been entered or who, although having such nationality, have in the past represented another ISU Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

GDPR

By registering for the event, all participants acknowledge and accept that personal data are collected by the Organizing Committee (OC) and such data are stored and used by the OC, and when necessary, third parties, for the purposes only of, and to the extent necessary only in relation to facilitate their participation in the competition; personal data may include but will not be limited to full legal name as per national identity documents, address, date of birth, nationality, sex.

All competitors must be entered through their Club which must be a member of the ISU Member, based on the age and the level of the Skaters.

Level of Competition: The 22nd Edition of Crystal Skate it is an InterClub Competition

Deadline for entries: All entries (competitors, judges, team leaders, coaches, other participants) are expected not later than **29th of December 2025**

Cancellation: Cancellation of the competitor entry, if any, has to be done till **4th of January 2026**

For any latter cancellation the Federations will be asked to pay the entry fee. In the event of withdrawal, no refunds will be given following the closing date on the 5th of January 2026. In the case of a “no-show” at the event, entry fee will not be refunded.

2. TECHNICAL DATA

Place of the event: Allianz Tiriac Arena - Drumul Garii Odai, Bucharest – Otopeni 075100 (near Henri Coanda International Airport).

The rink is indoor, heated. The size of the rink is 60 m x 30 m.

Ice Rink will offer surcharge a variety of snacks, coffee, and sandwiches.

Parking is available at the ice rink surcharge.

Date of competition: 14th - 18th JANUARY 2026

3. ENTRIES

Entries of Competitors :

Members of ISU / Clubs are invited to take part in this competition. Each Member / Club may enter an unlimited number of skaters in each category.

Please note: The Organizing Committee reserves the right to limit or refuse entries. Acceptance of additional entries will depend on the total number of participants and the capacity of the event.

For the Interclub Competition, all competitors must be registered through their Club, which must be affiliated with an ISU Member Federation, and placed in categories according to their age and skill level. All registration must be made at <https://forms.gle/w9wQsfLCbCp3h1qH6> , no later than 29th of Decembre 2025. This includes: entries of skaters and Music files of all skaters.

Entries submitted on and after 30th of Decembre 2025 will be considered late.

For each skater, the Program Content Sheet must be completed accurately in English, using the official terminology specified in the relevant ISU Communication. Program Content Sheets must not be handed directly to the acting Officials.

Withdrawal from the competition, if applicable, must be communicated no later than 4th of January 2026. Starting from 5th of January 2026, entry fees will not be refunded under any circumstances. If a skater has not been officially withdrawn by this date and the entry fee remains unpaid, the Club or Federation will be held responsible for covering the competition fee.

Official entries of Team Leaders, Team Officials, Coaches/Choreographers, Team Medical staff etc. must be made together with the entries for Competitors and Judges.

Entries of Judges and Technical Panel:

Each participating ISU Member has the right to nominate one judge per discipline who has at least the qualification "Judge for International Competitions". However, the OC reserves the right to limit the number of judges in accordance with the number of the Skaters' Entries. Confirmation for Judges will be sent to each Member immediately after the closing of entries. The members concerned will be notified of the result of the draw.

Each panel of Judges will consist of at least 5 Judges + Referee maximum two from the same country.

Entries of Team Members: Official entries of Team Leaders and Coaches will be accepted. Accreditation will be provided to those who are officially accepted by the Organizer.

4. MEALS, LODGING and TRAVEL EXPENSES

Expenses: The organizer will provide and cover the expenses for travel, rooms, and meals, from dinner on 13th of January 2026 until lunch on 19th of January 2026, for all Referees, the Technical Controllers, the Technical Specialists, the Data and Replay Operators and Invited Judges, during the entire period for which they are on duty.

Should any of the above-mentioned persons arrive at the hotel before or stay longer than the period described above, their room costs and expenses will be the responsibility of the individual and must be paid on arrival.

The organizer will not cover any expenses for competitors, team leaders, coaches or chaperons.

5. MUSIC

In accordance with Rule 343 in the ISU Special Regulations & Technical Rules Single & Pair Skating and Ice Dance, the ISU Member/Club is responsible for submitting their Competitor's music, until 29th of December 2025, attached at the registration form at <https://forms.gle/w9wQsfLCbCp3h1qH6>

Each submission must be labelled with the name of the ISU Member, name of the category, segment, the name(s) of the competitor and the exact running time of the music (not skating time).

Example:

The music files must be sent only as MP3 file formats. Any other format is not acceptable.

Please note: MP3 files may vary in playback quality. The Organizing Committee cannot be held responsible for any issues related to insufficient audio quality.

Each competitor must bring a USB stick containing a backup copy of each program's music in MP3 format.

The exact running time of the music (not skating time) must be communicated when submitting the file and will be verified at accreditation.

If music files are not submitted within the official deadline, they must be presented no later than at the time of accreditation, using the format and medium specified above.

The titles, composers and orchestras of the music to be used for the Short Program and Free Skating Program for Single, for the Rhythm and Free Dance Program for Ice Dance must all be entered, in detail, by the ISU Member or the Skater(s) on the dedicated ISU platform. If music information is not complete and music not provided, accreditation will not be given.

During accreditation, all submitted music will be played to verify its accuracy. If any issues are identified, the Team Leader or Coach may be permitted to replace the file by providing a valid MP3 version on a USB stick, which will be reviewed by the Organizing Committee's Music Team.

6. UNOFFICIAL PRACTICE

Unofficial practice will be available prior to the competition. Fees for additional practice sessions €20 per skater / 25 minutes – group practice, without music.

7. LIABILITY

In accordance with ISU Rule 119, it is the sole responsibility of each participating Member in The Crystal Skate to ensure that medical and accident insurance is provided for all athletes, officials, and other members of their delegation.

The Organizer assumes no responsibility or liability for any bodily or personal injury, or for property loss or damage incurred by Competitors or Officials in connection with the event.

Such insurance must guarantee full medical coverage and repatriation of the ill or injured person to their home country by air or other expeditious means.

It is the internal responsibility of each ISU Member to determine who will cover the cost of this insurance.

The Organizing Committee will provide on-site medical emergency aid during the competition.

8. ACCOMODATION

All delegations, must cover their accommodation expenses by themselves.

9. VENUE ACCESSIBILITY

The Allianz-Țiriac Arena Ice Rink is located directly across the road from Henri Coandă International Airport.

Transfers: Each ISU Member or Club is responsible for arranging their own transportation to and from the airport. The Organizing Committee will not provide airport transfers for competitors, coaches, Team Leaders, or other delegation members.

10. ACCREDITATION

Accreditation will begin on 13th of January, at the ice rink Allianz Tiriac Arena.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

The Organizing Committee has both the right and obligation to verify the passports of all athletes to confirm eligibility to compete and the correct category assignment. Athletes without valid identification documents will be excluded from the competition.

Passports of all skaters, as well as the ISU Clearance Certificate (if applicable), must be submitted during registration for verification.

11.DRAW & JUDGES MEETINGS

For Single Skating: Chicks, Cubs, Novice Basic, Novice Intermediate, Recreational & Adult categories the opening draw for the order of skating will be held electronically 13th of January.

The starting order will be available on <https://www.frponline.ro/> and at the ice rink.

Initial Judges Meeting – will be announced in the detailed schedule.

12.AWARDS

The Organizer provides diplomas for all competitors after each event. The three best Skaters in each category will be awarded with medals.

13.LIVESTREAM

Livestream video and photography will be provided during the event

14.ETHICS

All skaters, coaches, judges, and chaperones must comply with the provisions of ISU Communication 2641, or any updated version of this Communication.

Violation of this rule will result in the automatic disqualification of the skater.

15.GALA

No exhibition is planned at this event.

16.PROVISIONAL SCHEDULE

Please be informed that changes in the event schedule may occur depending on the final number of entries. For organizational efficiency, some categories may be rescheduled to a different day.

The detailed schedule will be published after the closing of entries. We kindly ask all participants to remain flexible and to consult the updated schedule once available.

17.TIMETABLE AND SCHEDULE FLEXIBILITY

In case of a large number of entries, the Organizer reserves the right to split groups according to age for optimal scheduling and fairness.

If fewer than 3 skaters register for a Singles Free Skating segment, age categories may be combined wherever possible to ensure a valid and competitive event.

RECREATIONAL and ADULTS CATEGORIES - TECHNICAL REQUIREMENTS

RECREATIONAL RISING STARS

A competitor in the Rising Star Free Skating event must perform a well-balanced program that may contain:

- Minimum 1 jump element and 1 spin element. A jump element with a half rotation may be accepted (waltz jump)
- There must be a spin element with a minimum of 2 full rotations. Spin on both feet may be accepted.
- The program must also contain 2 decorative elements, e.g. squat, one leg squat, lunge, spiral, spread eagle.
- At least 1 technical step/turn – Mohawk, three-turn, crossroll, etc. – must be included; chasses and crossovers are not counted as technical steps. This element has a fixed base value and will be evaluated by the judges in GOE only.

The first visible attempt to execute it will be contributed to the technical score.

Deduction for fall is 0.3 point.

The following Program Components are judged: • Composition • Presentation • Skating Skills

The factor for the Program Components is 1.67

RECREATIONAL BASIC

A competitor in the Recreational Basic Free Skating event must perform a well-balanced program that may contain:

- A maximum of four (4) jump elements. Only single jumps are permitted, no Axel type jump, no double or triple jumps can be included. There may be up to two (2) jump combinations. Jump combination can contain only two (2) jumps. Any jump cannot be executed more than twice in total.
- There must be a maximum of two (2) spins of a different nature (abbreviation) with change of foot (minimum 2 rotation per position, minimum 6 rotation in total) or without change of foot minimum of six (6) revolutions in total). Combo spin is allowed. Flying spin is not permitted.
- There must be a maximum of one (1) Choreo sequence which must be clearly visible. This element has a fixed base value and will be evaluated by the judges in GOE only. The first visible attempt to execute a choreographic sequence will be contributed to the technical score.

Levels explanations: For Recreational basic category, in all elements, which are subject to Levels, only features up to Level 2 will be counted. Any additional features will not be counted for Level requirements and will be ignored by the Technical Panel.

There may be up to two (2) jump combinations or sequences. Jump combination can contain only two (2) jumps. A jump sequence consists of 2 (two) jumps of any number of revolutions, beginning with any listed jump, immediately followed by an Axel type jump with a direct step from the landing curve of the first jump to the take-off curve of the Axel jump. Any single or double jump (including Double Axel) cannot be executed more than twice in total. Triple jumps are not permitted. • There must be a maximum of two (2) spins of a different nature (abbreviation), one of which must be a spin combination with or without change of foot (minimum two (2) revolution per position and minimum of six (6) revolutions in total) and one spin with no change of position and with or without change of foot (minimum of six (6) revolutions in total). Flying entry is allowed. • There must be a maximum of one (1) Choreo sequence which must be clearly visible. This element has a fixed base value and will be evaluated by the judges in GOE only. Axel type jumps, double jumps and triple jumps are not permitted. There may be one (1) jump combination in the free program. The jump combination may consist of two (2) listed jumps. Each listed jump may be performed a maximum of two (2) times. Waltz jumps will be ignored by the Technical Panel. • A maximum of two (2) spins of a different abbreviation, both of which must be a spin in one position with or without a change of foot. Flying spins are not permitted. The spins must have a required minimum number of revolutions: three

	<p>(3) for any spin with no change of foot, and six (6) with a change of foot. A spin that has no basic position with 2 revolutions will receive no value. All spins with change of foot must have at least 3 revolutions on each foot. If this requirement is not fulfilled, the spin will be marked with a “V” to reduce the base value.
